MINUTES OF PREVIOUS MEETING: Moved Kiel Sigley, seconded Graeme Ashley that the minutes of the previous meeting, 20th October, 2014, be accepted as a true and correct record.

MATTERS ARISING: Nil

ADMINISTRATOR'S REPORT:

Gary advised that after Round 5 in the One-Day Competition he had became aware that Forrestdale had played a player in a ODA match without a clearance from Canning Districts. Subsequently Forrestdale lost points for this match and were fined. As the player involved had played all games in ODA Thornlie believed that Forrestdale should lose points in all games played till the player was cleared. They seek the SMCA Executives consideration on this matter. After discussion the Executive supported Gary's decision to only penalise Forrestdale for the Round 5 match.

There are issues with incorrect results/scores being placed on MyCricket. Clubs need to work harder to get these results/scores correct. Captains need to regularly check scores, certainly during a change of innings, at the tea break and the end of the days play. Captains should sign the scorebooks and include the scores and the end of match result.

Rob Sims has resigned his position with Santa Fe Wridgways and will be taking up a new position with another company in Melbourne commencing in January. Rob's enormous contribution to our Association was acknowledged on last Saturdays Radio Show. The Executive also thanked Rob for his work over many years and wished him well in his new endeavors.

The fitness of grounds was discussed. Grounds are the responsibility of the Clubs and the local Councils. By-Law 20 covers the fitness of grounds; should a ground not be fit for play then the captains should decide this. Should no agreement be made between the two captains the decision shall then become that of the official

umpire/s. Should no umpire/s be appointed to the game a decision shall then be sought from the Match Day Referee.

Given a number of negative comments received about the standard of the Gilmore College Oval playing surface it was inspected by Graeme Ashley last Friday. Graeme deemed the ground unfit for play. The ODF match scheduled at the ground last Saturday was moved to Hume Road B. The Executive supported this decision and no matches will be played at the ground until the Kwinana Club report that it is fit for play and an inspection, including a member of the Executive, support that the ground is fit for play.

Gary reinforced that the By-Laws are in place for a reason and adhering to them was fairest on all Clubs.

This season the Fixtures and Gradings Committee has had to fall back on By-Law 51e to allow/force clubs to drop a team which was not normally within the rules.

One player has been suspended from bowling this season for a suspect action. This player has subsequently been cleared to bowl. Another player has been reported and banned from bowling from this past weekend.
