## ADMINISTRATOR'S REPORT:

#### **GRADINGS and FIXTURES:**

The Fixtures and Gradings Committee will work on the grading of First and Second Grade over the coming months. Hilton Palmyra indicated they would prefer to stay in First Grade. The position of Maddington is unknown; Bicton Attadale expressed interest in going to First Grade. An eighth team is required in Second Grade. These matters need to be resolved by the end of April to allow clubs to plan for the coming season.

The Executive directed the Fixtures and Gradings committee to do all they could to mirror grades, especially First and Third, Second and Fourth.

#### AGENDA ITEM:

President Graham Santich had brought forward the following items.

1. Umpires Advisor – I have discussed the position of Umpires Advisor with Ray Howe and he is keen to continue next season so I would ask that the Executive endorse his appointment accordingly. 2. Umpires Fees – I attended the Umpires meeting last night and they have requested an increase in their payment from \$110 to \$120 from next season. I suggested they formalise their request to you so it can be discussed on Monday night. I outlined the procedure where the Executive will discuss it and if it is supported will be forwarded to Cricket West. If the consensus of all associations in CW is reached it would then be likely that increase would be approved.

3. Cricket West Matches – Mark Holt has agreed to be manager/selector for our Colts team next season, which will be very helpful. I haven't yet officially approached Steve Matkovich for the Seniors but I would be fairly confident of him doing it again next season

4, Stand Alone First Grade Final 15/16 – In view of the later start to the season for 2015/16 (10/10/15) we may need to suspend the stand alone final next year so we can minimise the use of Sundays for home and away matches. I have completed a spreadsheet, which is attached.

The Executive endorsed Ray Howe as Umpires Advisor for the 2015-16 season. His salary will be considered after the umpire's request for a pay increase is finalised.

In relation to the ay rise for the umpires, the Executive is also in receipt of correspondence from the Umpires Association requesting a pay rise from \$110 per day to \$120 per day. The Executive supported the pay rise and will submit this support to Cricket West for consideration.

The Executive accepted that the stand alone First Grade Grand Final may not be possible next season, the Fixtures and Gradings committee to look at options.

#### GENERAL BUSINESS:

A General Meeting for all clubs will be held on Monday 4<sup>th</sup> May at Leeming. A General Meeting is compulsory; all clubs must be represented and will be fined if they are not.

There was discussion regarding the mid-season one-day final, some thought given to removing this final and ending the season with 2 one-day games.

The Life Members Committee put forward a nomination for Life Membership, which was accepted by the Executive. The Life Membership medallion is to be officially made at the SMCA Windup.

The SMCA Windup is next Tuesday, 17<sup>th</sup> March.
