ADMINISTRATOR'S REPORT:

All Team and Ground submissions were provided by the deadline.

GENERAL BUSINESS:

Any teams wishing to wear a form of coloured shirts must ensure the front of the shirt is predominately white. Logos are permitted, but may be no larger than 64.5 square centimetres. Logos should be restricted to each side of the chest and sleeves.

There was discussion on a Tuesday afternoon T20 competition, perhaps 15 overs a side instead of 20.

It was agreed to seek Expressions of Interest from Clubs with team nominations closing on Friday 30th October. Matches to be played on Tuesday afternoons during December and January. Each innings would be made up of 15 x 6 ball overs, the first 8 overs bowled from one end and the final 7 from the other.

SMCA One-Day rules to apply, red ball, supplied by each team.. Game to start at 5:00pm and be completed by 7:00pm. The SMCA will not charge any fees for participation and the umpire to be paid by the Association.

The competition needs a name and after discussion it was agreed on F15 or Formula15. A trophy is to be provided to the winning team.
