#### AGENDA ITEMS

#### **From Peter Anderson**

Peter advised that he had been contacted by a cricket ball supplier who could provide red and white balls that are more durable than the current Kookaburra ball, the ball is cheaper and has the tick of approval from Cricket Australia. Mark Iannello is to check with Cricket West regarding the current Kookaburra contract.

#### From David King

Dave is confirming with PlayHQ that our current points system is possible on PlayHQ.

Discussion There is concern that clubs can currently register new players without a clearance on PlayHQ. In cases where players have played for another other club and a Transfer (clearance) would normally be required, an email should be sent to the players former club ensuring that player is OK to play for the new club (doesn't owe money) - the SMCA Administrator should be copied in on this email. Transfers are only required from clubs affiliated with Associations in Cricket West. Should the SMCA become aware that players have changed clubs without a Transfer then penalties as per the By-Laws will be enforced.

Still checking to see if team lists can be printed on PlayHQ.

Discussion regarding clubs and two-day cricket. Push for all clubs who have two teams or more to have at least one two-day team.

# From Gary Hartman

Curtin Vic Park CC have requested to join the F15 competition this season. This was approved.

After discussion it was agreed that that the Belt Up Cup would continue with the winner representing the SMCA.

# **GENERAL BUSINESS:**

Steve Kemp brought up the issue of a player suspended and what to do if that player attended one of their matches. It was recommended that they call the police.

There was discussion on the booking of grounds. City of Gosnells is allowing City of Canning and City of Armadale clubs to book grounds before City of Gosnells.
