#### **ADMINISTRATOR'S REPORT:**

Gary thanks Ian for attending to minutes at the AGM.

Play HQ workshops are proceeding, David and Gary will participate in a further workshop on 1 August.

#### **CRICKETWEST:**

The executive confirmed that Mark and Sabrina would have full authority to make decisions on behalf of the SMCA.

#### **CONSTITUTION AND BY LAWS:**

The draft By-Laws were not proceeded with at the AGM. It is imperative they be dealt with at the General Meeting on 14 August.

#### **PROTESTS AND DISPUTES**

There is still an outstanding matter awaiting a decision by the courts, which has now been adjourned to August.

There was an issue with a player who has been banned by his club and the SMCA and who should have received a letter. This may not have happened. David King to send email to the player involved.

#### **FIXTURES AND GRADINGS**

Peter brought up the issue of playing the last round in two-day grades as a one-day match for two-day points. This has some issues in relation to the balance of the playing days, a one-day match would need to be played after Christmas.

Gary had distributed a draft set of playing dates with all one-day matches and the one-day final played before Christmas. The Executive endorsed these playing dates, and they are to be put to the clubs at the General Meeting on 14 August.

#### From David King

#### Clubs maintaining 3 sides.

All clubs that come into the competition have been advised that they need 3 teams. The By-Laws now reflect this. At the discretion of the board they have been allowed to come in with two and within 3 years they should have and maintain 3 sides. I believe that this should apply to all clubs and if for any reason that any club drops down to two sides for any period one of those must be a two-day side. Potentially we have North Baldivis entering the competition and they want to play two-day cricket initially with one two-day and one one-day side then build up to 4 teams. This probably should be taken to the presidents meeting then to the general meeting.

The Executive agreed with David and his comments and decided to have this brought forward to the General Meeting on 14 August.

It was agreed that all Executive items for discussion with the clubs should be brought to the General Meeting on 14 August. Matters for discussion at the President/Captains meeting on 31 July should only be matters brought forward by the clubs.

It was further agreed that the President/Captains meeting is not compulsory. However, the General Meeting on 14 August is compulsory for all clubs to attend.

#### **North Baldivis Admission to SMCA**

David King, Peter Anderson and Graham Santich met with representatives of the North Baldivis Club prior to the AGM. The club wishes to nominate 1 two-day side and 1 one-day side to the SMCA.

After discussion it was decided that North Baldivis will be allowed to join the SMCA starting this coming season on the condition that they agree to abide by the SMCA Constitution, By-Laws and Financial Rules. Current Club affiliation is \$1000 per season and \$250 per team. Further they will be required to have a third side within the next three seasons and at least one of them must be a two-day side. Cricket West to be advised of this matter.

#### One Day Game Completion and Points System

There was discussion regarding one day matches be completed when a result is achieved, and points systems should this occur. There is a precedent in other associations of having separate ladders for the one-day and two-day matches and the end of season finals being played only on two-day points. Other associations have the same system as the SMCA.

An Inter Association Competition Sub Committee was agreed upon prior to the meeting, Ian Del Rosso, Jacob Landsmeer, Mario Baeli.

#### **GENERAL BUSINESS:**

Mario brought up coloured clothing for Third Grade. This was not agreed to by the Executive.
