CRICKET WEST:

Steve Michael reported that the last Cricket West meeting had been at the WACA last Wednesday and he gave an overview of proceedings.

Steve advised that he had provided the SMCA's thoughts on the umpire's fees for the coming season and this matter was to be considered further at a future meeting.

Tim Park of the [North Suburban Community Cricket Association](#) was Cricket West Chairman for the coming season.

The Kookaburra sponsorship for seasons 2012 to 2017 had been agreed upon. The sponsorship involves \$100,000 over the 5 years. The Cricket West logo would be on the cricket balls. SMCA clubs should ensure that they purchase balls with this logo.

It was agreed that no clearance applications should be processed by Associations until the 1st of September.

It is anticipated that future Cricket West Association fixtures will be 40 overs for Seniors and Colts and 20 overs for Veterans.

The SMCA would participate in the Statewide Twenty/20 competition in the coming season

FIXTURES AND GRADINGS:

Fixture dates, would need to be one Sunday fixture this coming season.

The Executive discussed the issue of Clubs with more than two sides having at least one side in the two day (current First to Seventh Grade). This to be considered further

Nominations for two-day grades (current First to Seventh Grade) are to be submitted by 1st August. Nomination for the one-day grades is to be submitted by 1st September.
