## **GENERAL BUSINESS:**

Steve Nichols raised the matter of the condition of the pitch at Orelia Oval. No further 2<sup>nd</sup> grade matches will be played at this venue until this matter is resolved with the Council.

Prescribed Penalties: Clubs are reminded any player receiving a Prescribed Penalty notice has until 6pm Sunday following the match to accept or not the penalty. Failure to indicate acceptance by this time will result in the matter immediately being referred to the P & D Tribunal.

Finals Grounds – clubs are reminded of the provisions of By Law 36 (a) in regard to providing acceptable amenities for players and spectators. In the event that a club can not comply with this By Law the Executive retains the right to re-locate the fixture.

### *36a. HOST CLUB:*

- i. Provide change rooms for each team.*
- ii. Mark pitch and boundaries and see that popping crease is extended 2 metres each side.*
- iii. Place markers on boundaries.*
- iv. Provide facilities for the making of afternoon tea, i.e. hot water, cups.*
- v. If contacted by clubs possibly supply tea, coffee, milk etc. at charge.*

Rain effected matches: Agreed to review the rules regarding no play on the first day of a two day fixture, especially in regard to playing day two under 2 day rules.
