#### PROTESTS AND DISPUTES

11th February 2009 D Perry - Thornlie - charge of misconduct. Plead not guilty. Charge proven but in light on contradictory evidence a severe reprimand was issued. No suspension.

D Rourke - Phoenix - Prescribed penalty for intimidating an umpire by gestures or words. Charge downgraded to misconduct. Charge proven, the original 3 match suspension was suspended for remainder of 2008/09 and all of the 2009/10 season.

M Beer - Phoenix - fined \$50 for an outburst directed at the P&D during Rourke hearing.

16th December 2008 - deferred to 4th February 2009 K Schreck, Riverton Rostrata - charge of misconduct by disputing an umpires decision. Player was unable to attend P&D hearing and was suspended until such time as he does.

K Schreck appeared before the P&D on 4th February and was found guilty. 2 day suspension being 7th and 8th February.

**Permits** – Gary advised that as per last month, still getting a lot of permit requests and is very difficult to be consistent. He believes that issue of permits needs to be reviewed over the off season to come up with a better system. It was agreed that the issue of permits will again be discussed at the next meeting and that Club input be sought.

There has been a slight reduction of games in ODC due to byes. It was decided not to reduce the number of games to qualify for the finals.

#### **UMPIRE'S ADVISOR REPORT:**

We have about 30 umpires for the forthcoming semi finals – need around 10 more. Umpires will be paid \$100 and if only 1 umpire then \$150.

#### **CRICKET WEST:**

Ian Hale reported the Cricket West meeting had been rescheduled to tomorrow night.

In last weeks games the seniors lost and will not play in the finals. Both the Colts and Veterans won and will play in this Sundays finals.

It was moved Ian Hale and seconded Bill Greenshields that the reports be accepted. CARRIED
