It was decided not to support an Internet Forum given the possibility of inappropriate feedback.

The letter regarding the incorrect closure of a match was discussed and it was decided that the points allocated to both clubs should be amended using a formula previously used in a similar situation by the PCA.

The letter from Phoenix regarding permits for the mid season one-day finals was discussed. It had previously been the Executive's intention that when the playing dates to qualify for finals was reduced from 8 to 6 that there be no permits for finals, mid or end of season. After further discussion it was decided, 6 votes to 1, that there be no permits for players, not normally qualified, to play in finals.

The letter from Southern River referred to when the qualifying period for mid season one-day final ended – after the one day competition or after the subsequent two days of cricket. It was decided by the Executive that the qualifying period for the mid season one-day final should include all cricket played until the final on 1st February. This means that the two days of cricket subsequent to the end of the one day games (24th and 31st January) shall be included in a players qualifying period to play in the mid season one-day final.

It was moved Terry Garner and seconded Ian Hale that the previous minutes are accepted as a true and correct record and that the correspondence be accepted. CARRIED

There was discussion about the ball rebate from Kookaburra. Rob suggested that as most clubs did not claim this rebate that the Association claims the rebate on the clubs behalf. Rob will investigate further and report back.

Ian Hale advised that, after sponsorship, the cost of the radio show was \$150 for the past two seasons. It was moved Ian and second Bill Greenshields that the Association pays the outstanding \$150.

UMPIRE'S ADVISOR REPORT:

Terry Kift advised that we had lost 6 umpires since Christmas and only picked up one new umpire.

It was felt that, given the current economy, that it was the right time to again advertise for new umpires. This will be done on radio and community news.

Cockburn cricket club each Thursday night provide Terry Kift with a list of players who are injured and may be interested in umpiring. Perhaps other Clubs could do this also.

CRICKET WEST:

Ian Hale reported that the Bunbury v Cricket West XI at Bunbury was a success with squads of fifteen in seniors and colts. There were three players from each association in each team, a total of 6 players from SMCA.

Innaloo Cricket Club has been suspended by the Perth Cricket Association.

Cricket West Grand Finals, Seniors and Colts as well as the Cricket West windup will be held at Charles Varyard Reserve, North Perth on Sunday 22nd February 2009. The Veterans will be held at Wyong Reserve, Bentley.

Cricket West fixtures on Sunday 18th January saw losses by SMCA in all grades. Seniors; Swan Helena 229 beat SMCA 91. In the Colts, SMCA 79 beaten by Swan Helena 0-82 and in the Veterans Swan Helena 351 beat SMCA 173.

It was moved Terry Garner and seconded Roy Gibson that the reports be accepted.

CONSTITUTION AND BY-LAWS COMMITTEE:

Vote for accepting new Constitution and By-Laws closed on 4th December.

The vote on the new SMCA Constitution and By-Laws resulted in a yes vote. 18 of the 21 Clubs voted YES, 1 voted NO and 2 clubs did not vote.

The new rules have been lodged with Department of Consumer and Employment Protection and we await their confirmation. Until then the old Constitution and By-Laws remain the Associations rules.

GENERAL BUSINESS:

There was general discussion regarding a SMCA Windup for this season, possibly Wednesday evening before the First Grade Grand Final. It was eventually decided that it was too late to organise a function for this season but that a sub-committee be formed to look at a windup for next season. Terry Garner to form the committee and consideration be given to including a First Grade Cricket of the Year count on the night.

Terry Garner requested approval of Armadale's Morro Day cap for all grades except First Grade. This was approved.

Steve Michael advised that a potential winter competition was taking shape. The games to be played at Coker Park in a 20/20 format. Games will be played once every 2 to 3 weeks.

Rob Sims brought up the issue of the Working With Children legislation. It was decided that at the next meeting Steve Michael to form a sub committee to better address this issue.

Rob Sims discussed the issue of a Strategic Plan for the SMCA. Where do we want the Association to go? David Clear of the WACA would be happy to assist. This matter to be an agenda item at the next meeting.
